COASTAL SOLACE stalked the pace, circled the turn, drifted in and bumped with BILL'S JEWELL in midstretch then drew out under urging. BILL'S JEWELL , two wide, disputed the pace, drifted out and bumped with COASTAL SOLACE in midstretch then weakened. TOWN JET had speed along the rail and gave way. DOVE CHARM raced along the rail and gave way. COAL VALLEY , wide, was outrun. EXTRIA was outrun. An objection by the owner of BILL'S JEWELL against the winner for alleged interference in midstretch was not allowed.
