Footnotes

CHESAPEAKE DANCER , wide around the turn, swept to command inside the eighth pole and pulled away under energetic urging. BONBON VIOLETTE sped to the front, set the pace well off the rail, weakened and was second bests. RUFFY TUFTY saved ground in a willing effort. RAVEN POINT saved ground and passed tired rivals. CITRON LADY saved ground, was steadied on the heels of a rival near the three sixteenths pole, swung out and finished willingly. DANCE OFF bore out leaving the starting gate, raced in the three path on the turn, drifted in near the three sixteenths pole and failed to rally. BOOTH BAY , wide on the turn, was outrun. ALPHABET TIME , pinched back leaving the starting gate, was outrun. SOUL PLANE , bumped and forced out a bit leaving the starting gate, chased the pace three wide around the turn and faltered in midstretch. CAFE RENDEZVOUS , very wide turning for home, was outrun. SCARLETT D'HEREA was outrun. DIANA GIRL circled the turn three wide, chased the pace to the stretch then stopped.
