FRESHBROOM circled the turn, raced wide in upper stretch and closed. LILYCAKES stalked the pace three wide and gave way. BELIEVE IN PRAYER had speed along the rail and gave way. KYLE'S LADY was outrun. SLIVER OF SILVER stumbled leaving the starting gate and was pulled up lame. .
