WISDOM SEEKER broke a step slow then was pinched back soon after, settled back in about the two path, was sent up between rivals into the turn, angled out past the three furlong marker, circled five wide into the stretch, rallied to collar ATLANTIC TIDE nearing the furlong marker, drifted in and drew clear under a drive. QUITE AN ECLIPSE moved between foes into the turn, dropped inside chasing the pace mid turn, advanced along the rail in upper stretch, worked outward nearing mid stretch and finished willingly to be clear for the place. CASEY ON THE RUN , well back for a half mile, swung out very wide past the three sixteenths marker, rallied and just got the show. ZIRCON , hustled along off the rail, gained some in the two path in upper stretch, shifted in and came up empty. ATLANTIC TIDE sprinted clear early, set a quick pace along the rail, was collared approaching the furlong marker and weakened. DONTPLAYWITMATCHES , bumped at the start, chased the pace while off the rail, was in close in mid stretch and weakened. BLUEGRASS ZIGGY , bumped at the break, chased the pace off the rail, came four wide for the drive and faded. DIPPITY broke outward, lacked speed, angled four wide into the lane but failed to menace. AUTUMN'S DISPUTE chased the pace while saving ground and weakened. EDIBLE PETAL , three to four wide, lacked a

response. KAWAII KAT , well wide, dropped back before going a half mile. ELPHABA broke awkwardly, recovered and made some progress four deep into the turn, chased around the turn then gave way in the drive.
