Footnotes

PRINCE WOODMAN , pinched back leaving the starting gate, raced four wide around the first turn, five wide the far turn, gained a clear lead in midstretch and lasted. BROKERAGE HOUSE , three wide between horses on the far turn, eased out in midstretch and closed outside the winner. PHOENIX HEAT lacked speed, raced very wide around the far turn and rallied. FRISKY THUNDER chased the pace three wide, gained the lead midway on the far turn and weakened in the drive. MACH THREE , wide the far turn, weakened late. WARRIORINTHESKY , wide the far turn, gave way in midstretch. MY DREAM (BRZ) , no factor, raced wide on the far turn. CROW'S NEST lacked speed and was no factor. MABOU advanced four wide on the far turn and gave way in the drive. TOYMAKER dueled two wide and was checked in tight quarters entering the stretch. COME CLOSE , between horses the far turn, gave way in the stretch. WOLF HOWL was outrun. TAM'S TERMS saved ground disputing the pace and was checked in tight quarters near the five sixteenths pole. Objections by the riders of TOYMAKER and TAM'S TERMS against BROKERAGE HOUSE for alleged interference on the far turn were not allowed.
