ODDS AND EVENS lacked speed, raced very wide entering the stretch, closed and drew out under energetic urging. CALOCAGATHIA sped to the front, set the pace along the rail and tired in the drive. PLEASANTLY BLONDE , wide around the turn, flattened out. AMERIGLEN , two wide, chased the pace to the upper stretch then weakened. RED DIRT GIRL saved ground and weakened. TIS AUDREY'S TURN , three wide, chased the pace to the stretch then gave way. MIAVA saved ground and was outrun. SURFING IN MALIBU , three wide, chased the pace to the turn then stopped.
