**Footnotes**

BOOT THE BOSS lacked speed, raced wide around the turn, was fanned to the six path in upper stretch, closed and was along in time. KENS CAPE dragged his rider to the lead, set the pace along the rail, opened up in midstretch and weakened late. COUNT ON LOU lacked speed, was steadied in tight quarters near the three and a half furlongs pole, was steadied in close quarters near the five sixteenths pole, swung to the six path in midstretch and rallied. SPRINGS ROAD saved ground and rallied mildly. ROUGH ROAD AHEAD circled the turn, chased the pace, was fanned wide in upper stretch and gave way in the drive. BREEZY BOY chased the pace outside KENS CAPE and gave way in midstretch. CUTTER chased the pace between horses and gave way. WINGED HERO, inside horses to the stretch, gradually weakened through the lane. DELAUNAY unseated his rider when stumbling soon after the break.
