LEBRONS LION chased the pace, moved up three wide entering the stretch, took command approaching the eighth pole then drove clear. KAREN'S SAINT came in when breaking sluggishly, rushed up along the rail down the backstretch, steadied and altered course to the outside of HARK THE HERALD near the eighth pole then closed gamely. MR. TIME TO GO saved ground, eased out to the three path entering the stretch then rallied. HARK THE HERALD sped to the front, entered the stretch in the two path, drifted in near the eighth pole and weakened. GLENN'S HOPE , inside horses in upper stretch, angled to the four path in midstretch and finished willingly. DUMPLING KING was not a factor. MALIBU MADNESS , steadied in traffic near the five eighths pole, raced wide on the turn and was not a factor. ZANIMAL , three wide on the turn, gave way. THE ADMIRAL'SFLANK , wide on the turn, entered the stretch in the five path and gave way. SWEEP FIRST trailed.
