Footnotes

MCNAMARA , three wide between horses on the turn, angled to the two path in upper stretch, closed determinedly between horses and prevailed in a hard drive. DEVILISH GAIT lacked speed, moved up in the six path entering the stretch, challenged for the lead near the eighth pole, raced on his left lead and hung. BIG BAND SOUND , unhurried on the turn, swung six wide entering the stretch and offered a late rally. CLASS RULES sped to the front, set the pace along the rail and weakened late. COOPER JUNIOR , in the five path between horses turning for home, failed to rally. SURTAX raced well off the rail and passed tired rivals. FUTURE COVENANT , wide on the turn, had aim on the lead entering the stretch then gave way. PORONUI circled the turn, chased the pace and faltered. TREY BEAR was outrun. COWBOY KEVIN chased the pace two wide to the turn and stopped in upper stretch.
