Footnotes

GO ANGEL GO lacked speed, angled to the six path in upper stretch, closed while attempting to drift in and was along in time. MICHAELS VOW , five wide around the turn, flattened out between horses. ELEMENT OF GOLD stalked the pace, circled the turn, gained a clear lead entering the stretch and weakened in the drive. WELL STONED lacked speed and rallied in the eight path. I'M OK chased the pace, raced in the four path entering the stretch and gave way. BERNIE'S STORM CAT raced five wide and failed to rally. SEA THIS dueled along the rail and weakened. SPEEDY LION dueled two wide and gave way. DISCO DUDE faltered.
