### Footnotes

AFTERNOON ACTION disputed the pace four wide to the turn, dueled three wide around the turn and into the lane, drifted in when moving clear nearing the three sixteenths marker, raced on his left lead and held sway under a drive. WICKED THUNDER rated close up while saving ground, shifted out three wide in upper stretch, worked his way between rivals leaving the furlong marker, switched to his left lead and continued on gamely to steadily close the gap. FRED HIGH , allowed to settle while never far back, ranged up four wide into the stretch then flattened out in the final furlong. MOVING WEST , within range, came five wide for the drive but lacked a rally. SKY MAGGY disputed the pace inside the winner, checked when put in close between rivals near the three sixteenths pole, altered out and faded. DINNY DINOSAUR rated close up while two wide and between horses early, lodged a bid inside rivals past the half mile marker, dueled into the lane then weakened in the final sixteenth. BOB BOB'S BOY settled back early, made a mild four wide run nearing the half mile marker, chased the leaders and faded. An objection by the rider of SKY MAGGY against the winner for alleged interference in the stretch was not allowed
