JUST JONESY accelerated to the early lead, set the pace along the rail and was never challenged while under urging in the drive. GO FOR TWO circled the turn, was floated wide entering the stretch, shut off ARMI BASE when lugging in approaching the eighth pole and rallied. ARMI BASE shut off CONNOR THE CONCH when bearing in about a sixteenth of a mile after the break, raced in the two path on the turn, was steadied on the heels of BLACK SEAL when that one drifted out in front of him entering the stretch then was steadied when shut off by GO FOR TWO approaching the eighth pole. BLACK SEAL saved ground chasing the pace, drifted out entering the stretch and gave way. SOMEONES LION , wide entering the stretch, passed tired horses. CONNOR THE CONCH , checked when shut off by AMERI BASE about a sixteenth of a mile after the break, was very wide on the turn and rallied late. DELIRIOUS TIDE , wide on the turn, was not a factor. LAIRD ARCHIE chased the pace, turned for home in the three path and gave way. BREEZY LOUIE was outrun. RED HOT ROCK , steadied in close quarters along the rail leaving the backstretch, gave way. MONDOCAT hugged the rail leaving the turn and dropped back in the stretch. Following an objection by the rider of ARMI BASE, GO FOR TWO was disqualified and placed behind that one for interference

in mid stretch. Following an objection by the rider of CONNOR THE CONCH, ARMI BASE was disqualified and placed behind that one for interference soon after the break.
