Footnotes

CAYMAN CONDO stalked the pace, raced wide around the turn, gained the lead approaching the eighth pole and edged clear. PRIDE PARK saved ground, angled off the rail entering the stretch, drifted wide in midstretch and rallied. DECOLATOR , three wide on the turn, chased the pace, bid for the lead in upper stretch and tired the final furlong. MONEY FOR LOVE , checked when pinched back leaving the chute, was floated to the six path entering the stretch and passed tired horses. FUNNY BOOK , swung to the five path entering the stretch, came up empty in the drive. PERSONAL GOOD chased the pace two wide, drifted out in upper stretch and faltered. HALLUCINOJENIC raced well off the rail on the turn and was not a factor. GLOWING PROMISE set the pace near the rail and faltered in upper stretch. MR. EMANCIPATOR dropped back and was eased late.
