Footnotes

APPEAL TO THE CITY showed speed along the rail, sprinted clear in midstretch and held sway under a hand ride. BINDLOE , unhurried early, raced very wide entering the stretch and rallied while drifting in. SEACLIPSEOFTHMOON raced between horses and rallied mildly. BOB'S VALENTINE had speed in the two path and weakened. BANKCARD raced between rivals and weakened. SING TO THE SKY lacked speed, raced very wide and passed faders. GATOR'S TRACKS was no factor. JE SUIS PREST was outrun. PRINCESS DEE raced wide, weakened and was caught in close quarters near the three sixteenths pole. DANCIN 'N GROOVIN pressed the pace three wide and faltered. FOX'S CAROLINE was outrun.
