### Footnotes

STRATORIDGE hugged the rail, disputed the pace, opened a clear lead entering the stretch and was kept under pressure in the drive. SURROUND SOUND , two wide on the turn, angled to the three path in upper stretch and rallied nicely. JUSTICE DENIED saved ground on the turn, eased out in upper stretch and rallied mildly. NO FLASHLITE circled horses on the turn, floated to the six path entering the stretch then passed tired foes. D' WILD ANGEL dueled outside the winner and weakened. WACHACHA , in the two path on the turn, was outrun. SPEIGHTSLEGACY drifted to the four path leaving the turn and faltered. WHO LOVES YA BABY , three wide on the turn, chased the pace, floated to the five path entering the stretch then stopped.
