### Footnotes

TOUCH THE BIRDS , bumped at the break, recovered and moved clear early, set a rated pace, widened off the rail when asked into the stretch, was joined from the inside in deep stretch, dug in and held gamely to be on even terms at the wire. CARRIETTA settled off the pace, angled inside leaving the far turn, closed steadily under right handed pressure and drew even with TOUCH THE BIRDS in the final yards. BELIEVE IN A. P. came out at the break bumping BE MY CANDY, angled off the rail into the backstretch, stalked the pace, came under pressure around the final turn, chased into the stretch but came up empty. BE MY CANDY , bumped at the break, had a three to four wide trip chasing the pace and lacked the needed response. CROSS MOUNTAIN lagged back and failed to threaten.
