SUMMER REVIVAL chased the pace outside ALLUSEEISMYTALE, over took that one in upper stretch then drew off under brisk urging. BAT CAVE lacked speed, raced in the two path on the turn and closed inside horses late. YANKEE MICKEY circled the turn, floated to the four path entering the stretch and flattened out the final furlong. BRAWL , outrun to the stretch, swung to the five path in upper stretch and passed tired rivals. PROUD TRICK hugged the rail on the turn and failed to rally. ALLUSEEISMYTALE , sent to the early lead, set the pace along the rail, drifted out in midstretch then gave way. JUDGE WYLIE chased the pace three wide around the turn then faltered in the drive.
