GRANTED RULER, well rated on the lead towards the inside, was taken on by RADIO RELAY mid way on the final turn, dueled in the three path inside that rival into the lane, edged clear a furlong out and dug in under a drive. LUCKIFEE settled off the rail, commenced a run while under ride leaving the three eighths pole, came four wide for the drive, angled out a bit wider and closed gamely through the final eighth. RADIO RELAY prompted the pace outside the winner, moved to challenge past the three eighths pole, dueled in the four path into the stretch, drifted out some late and gave way grudgingly. REHOBOTH moved closer along the inside leaving the five eighths pole, swung out and came four wide for the drive but came up empty. LORD KIPLING saved ground, advanced into the far turn, was put to a ride past the three eighths pole, chased the leaders into the stretch and faded. ENIGMATIC was outrun. COURT BAND lacked speed, saved ground into the lane and never threatened.
