Footnotes

THIS ONES FOR PHIL dueled outside DISCO'S SON, opened a clear lead leaving the turn, steadily increased his advantage under urging. MALIBU KID , three wide leaving the turn, chased the winner and was second best. TORPEDO RUN , in close quarters leaving the starting gate, swung wide turning for home and flattened out. PEACE TOWN , two wide on the turn, chased the pace and gave way. BASHA'S MOON lacked speed and was not a factor. ROCK ON JUSTIN , unhurried early, swung wide entering the stretch and was outrun. DISCO'S SON saved ground, disputed the pace and faltered in midstretch.
