PEPPER JOANN lacked speed, hugged the rail on the far turn, swung to the five path in upper stretch and rallied. PIETRA DURA , in the three path between foes the far turn, failed to rally. BETHANY BREEZE moved up in the four path on the far turn then came up empty in the stretch. CLEVER ANSWER stalked the pace two wide and gave way. SMOOTH APPROACH , outside horses, dropped back on the far turn. HOLLYWOOD CORNER saved ground and faltered. RAY DE LIGHT was outrun.
