**Footnotes**

SIMMDOWNNOW , away well, rated back off the leaders and stalked under a light hold, got through along the rail lodging a bid mid turn, edged clear into the lane, opened up when set down, drifted off the inside and proved much the best under a drive. FIB , off the pace while removed from the inside, angled five wide in upper stretch and finished with good energy to gain the place. ANY OTHER NAME settled early, advanced three wide nearing the lane, dropped to the rail in upper stretch and kept on willingly. PENNIE MY LOVE was maneuvered to the rail early, gave hard pursuit mid turn, followed the winner making a run in upper stretch, shifted out in mid stretch but failed to sustain in the final furlong. PAY THE LADY , taken to rate early while off the inside, commenced a run leaving the half mile marker, ranged up four wide past the five sixteenths marker, chased to mid stretch then weakened. BUCARAMANGA failed to menace. KOPP AN EYE FULL stumbled at the break, pressed the pace three wide and tired in upper stretch. PURR AND PROWL failed to keep pace. REDISTHEROSE , hustled to the front, set a pressured pace while off the rail, relinquished command past the five sixteenths marker, faltered and was eased late.
