RYAN'S FOR REAL chased the pace, bid for the lead outside OROZCO entering the stretch and drew off while kept to his business. APPEALING SPEED , unhurried early, swung wide in upper stretch, raced on his left lead and rallied. INISH SHANK , unhurried early, swung outside entering the stretch and failed to sustain his bid. NASHLY'S RUNNER , very wide entering the stretch, weakened. MEGA MOOSE lacked speed and was not a factor. MICHAELISTHEONE , outrun, raced very wide in the stretch. OROZCO set the pace along the rail and faltered. SEA HERO'S GHOST was outrun. JOEL'S TOUCH , two wide, chased the pace and faltered.
