ANGELA'S MEMORIES chased the pace three wide, closed determinedly under strong left handed urging and overtook VERONICA'S LAKE in the final yards. VERONICA'S LAKE sprinted clear early, set the pace along the rail, widened around the turn, remained well clear past the furlong marker, finished gamely but could not contain the winner. CONGRESIONALAFFAIR lagged well back for three furlongs, raced wide in the drive and got going too late. UVADA chased the pace while saving ground, angled out near the quarter pole and failed to generate a solid response. GOLD FOREST chased the pace two wide and tired near mid stretch.
