Footnotes

DE CHERA saved ground setting a pressured pace and drew off the final furlong while kept to his business. CAJUN QUICKSTEP , three wide the first turn, prompted the pace outside the winner on the far turn and faded in the drive. GOODLOOKINRED saved ground on the far turn, eased out entering the stretch, reached a striking position near the three sixteenths pole then gave way. RED RIVAL , nicely rated back early, saved ground and failed to rally. PATROL LEADER lacked speed, raced wide on the far turn and failed to rally. ANTHONY THE TIGER , wide the first turn, chased the pace to the far turn then gave way. SAY CHEESE raced along the rail leaving the far turn and was not a factor. FOX RED raced along the rail, drifted very wide entering the stretch and fell back. LION'S SHARE , three wide the first turn, dropped back. DIXIE THIEF stalked the pace two wide and gave way on the far turn.
