TREE MON saved ground under patient handling, eased out to the two path entering the stretch, split rivals inside the quarter pole, was under brisk urging in the stretch and eagerly pulled away. NEVER COUNTED OUT, wide on the turn, had a slight rally. RISKY RIVER saved ground stalking the pace, angled to the three path entering the stretch, chased the winner through the lane and weakened. TIME TO SET SAIL, in the four path turning for home, failed to rally. A AND E UPGRADE raced in the two path on the turn then gave way. ROCKET NINETYEIGHT gave way. BATHE ME IN GIN, pinched back soon after the break, was not a factor and left the turn in the four path. WILL I EVER was outrun. SEMINOLE VICTORY stumbled leaving the starting gate, rushed up inside horses to make the lead, remained prominent to the stretch then stopped.
