**Footnotes**

DADDYROE rushed up along the rail down the backstretch, briefly steadied entering the turn, advanced along the rail around the bend, sprinted clear in midstretch, drifted out badly near the sixteenth pole and lasted under energetic urging. AVENIDA PASEO lacked speed, raced off the rail on the turn, angled to the six path in upper stretch and closed gamely. SMILEFORTHECAMERA , three wide between horses leaving the turn, chased the winner, drifted out behind that one near the sixteenth pole and lacked the necessary late response. MISTER MEEHAN showed speed in the two path and weakened the final furlong. VOWS TO BE BROKEN , five wide around the turn, had aim on the lead in upper stretch then failed to sustain his bid. ISSUES AND ANSWERS , swung wide in upper stretch, passed tired foes. SACHICOMULA , wide on the turn, weakened. REGAL STRIKE , outrun, raced wide entering the stretch and was carried out in upper stretch. DUNRAVEN LAD , fractious behind the starting gate, chased the pace three wide and was done early. WILDCAT GLORY saved ground and gave way. An objection by the rider of SMILEFORTHECAMERA against the winner for alleged interference in the stretch drive was not allowed.
