**Footnotes**

MONTY'S APPEAL disputed the pace outside GO SIX GO and drew away through the stretch while under steady encouragement. GOGO BABY , between horses on the turn, angled out for the drive, was fanned very wide in upper stretch and rallied. WOODLAND FLUTE , four wide on the turn, angled in a bit entering the stretch, worked between horses and rallied mildly. GO SIX GO bore in at start, saved ground, disputed the pace, came out a bit for the drive, raced on his left lead and weakened. STORDDIM , swung wide entering the stretch and passed tired foes. PRIVATE NOTICE , drifted wide leaving the turn and weakened. SECRET SLIDE , outrun, was five wide turning for home and passed tired horses. WIRE FUNDS saved ground and weakened. BOSTON POP , no factor, had a ground saving trip. SILURO , pinched back leaving the starting gate, gave way approaching the stretch.
