### Footnotes

HANALEI BAY , unhurried early, swung wide midway on the turn, closed determinedly and drove clear. GEE'S BEND set the pace along the rail and gave way. CONTEMPLATION , three wide on the turn, raced evenly. SONG BOOK saved ground and raced evenly. A PASSING MOTION raced along the rail and was no factor. CHELOPECH bobbled leaving the starting gate, swung to the seven path in upper stretch and was outrun. BELLE'S REEF , two wide, chased the pace and gave way. TRUTHFUL DUTCH , two wide between horses on the turn, gave way. DOOTS , outrun, raced very wide. MRS. MOTTE stumbled leaving the starting gate and was outrun.
