Footnotes

SHAMSS stalked the pace three wide, rallied four wide to command nearing mid stretch then eagerly drew clear under a drive. A BRIDLED TIGER , away alertly, set a pressured early pace towards the inside, shook clear around the turn, came two wide for the drive, drifted back to the rail nearing mid stretch and gave way grudgingly. VICTORY STORMER lost ground four wide between rivals, raced five wide in upper stretch, ducked out under left handed urging in mid stretch impeding ESCROW ACCOUNT then lacked a solid late response. ESCROW ACCOUNT lost ground five wide to the quarter pole, raced six wide in upper stretch, checked when impeded in mid stretch then came up empty. SIR MANUS saved ground around the turn and failed to respond. HORACE G. pressed the early pace two wide and gave way nearing the lane. Following a stewards' inquiry and objection by the rider of ESCROW ACCOUNT, VICTORY STORMER was disqualified from third and placed fourth for interference in the stretch.
