ROYAL STEPPER was away awkwardly then bumped with a rival, settled off the pace, ranged up while three wide on the far turn, steadied while blocked from the top of the stretch into the final furlong, moved to the outside and closed with a rush late to get up at the wire. ONACAT raced four wide on the first turn, settled towards the rear, moved closer on the far turn, steadied while blocked from the top of the stretch into the final furlong, moved in and rallied to the lead but was denied. ALKELINE bumped with rivals after the start, raced three wide on the first turn, settled of the pace, was forced five wide midway through the far turn, closed well to get the lead in upper stretch, led into the final furlong but just missed in a desperate finish. PARIS FRANCE (FR) bumped with a rival after the start, settled off the pace, was forced four wide midway through the far turn, steadied sharply while in tight nearing the furlong marker and finished willingly but couldn't recover. CHIEF I THIRTYFIVE lagged towards the rear of the field while saving ground, moved closer on the far turn, was blocked from the quarter-pole to the eighth-pole, altered course to the outside and finished willingly but also couldn't recover. LAM'S SHOWNTELL brushed with a rival at the start, prompted the pace on the outside, dueled on the far turn, battled into the final furlong and was outfinished. DO YOU SEE ME NOW broke outward and brushed with a rival, settled in third, shifted three wide midway through the far turn, made a bid in upper stretch but was also outfinished. DANCE ALL THE WAY bumped with a rival after the start, lagged near the back, swung seven wide into the stretch and lacked the needed kick. TEXAS GRAN ZAR set the pace through solid fractions, dueled inside on the far turn and gave way. Following a stewards' inquiry, ALKELINE was disqualified from third and placed fourth for interference in upper stretch. (Rail at 0 Feet)
