**Footnotes**

IN A TWINKLING raced four then three wide on the first turn, was well rated while setting the pace, came under pressure while inside on the far turn, responded well when asked for her best in upper stretch and edged clear under strong urging. WHERE'STHEDOVE went five then four wide on the first turn, tracked the pace, made a bid on the far turn, lost touch with the winner nearing the furlong marker and was outfinished while able to get the place. OFFICE MORGAN went four wide early on the first turn then dropped to the rail, lingered well back in the field, saved ground early on the far turn, came off the rail near the quarter-pole, moved out in upper stretch and finished with good energy to get the show. ALEDO LADY was sent hard from the start, raced off the rail early on the first turn then dropped to the inside, settled off the pace, was urged along while inside on the far turn and failed to rally. MOLLY MAGNOLIA went six then five wide on the first turn, was forwardly placed on the outside, chased three wide on the far turn and came up empty. SWEETSFORTHESWEET saved ground on the first turn, settled off the pace, went four then five wide on the far turn and failed to respond. CATALINA

LADY was urged along on the backstretch, went mostly three wide on the far turn, raced behind rivals into the stretch and failed to threaten. STICKER PATCH CAT settled towards the rear, went two then three wide on the far turn, shifted five wide into the stretch and was no factor. ALLURE went four then three wide on the first turn, settled off the pace, was urged along while three to four wide on the far turn and had nothing left. ST. REGIS prompted the pace, dropped back midway down the backstretch, was urged along while off the rail on the far turn and capitulated. JOSEPH COUNTDOWN came out at the start, went four wide on the first turn, was urged along on the outside, went five then four wide on the far turn and faltered.
