Footnotes

ANNIE'S HONOR was urged along on the inside, moved around ADVOCATE ANNIE inside the five-sixteenths marker, angled back to the rail at the top of the stretch, made a bid near the eighth-pole, took the lead inside that marker then edged clear under right hand urging. BOBBINJEAN raced four wide on the first turn, settled on the outside, moved closer while three wide on the far turn, shifted to four wide near the quarter-pole, loomed a threat into the final furlong but finished evenly and settled for the place. FLYING VIXIE DUST broke outward and bumped with a rival, settled while three wide, ranged up while still three wide on the far turn, took the lead at the top of the stretch, lost the lead inside the furlong marker and weakened. QUEEN OF THE ISLE raced three wide on the first turn, contested the pace on the outside, vied into the final furlong and tired. SMART APPEAL raced three wide to four wide on the first turn, was rated at the back of the field and failed to threaten. ADVOCATE ANNIE was bumped at the start, contested the pace on the inside, dropped out nearing the quarter-pole and stopped.
