Footnotes

UP AND OUT OF SITE broke a bit slow, moved up on the outside, raced four then three wide on the first turn, contested the pace on the outside, battled with STAND in the stretch and inched clear late under strong urging. STAND was hustled from the start, raced three then two wide on the first turn, contested the pace between rivals, vied inside on the far turn, battled with the winner in the stretch and was outfinished late while clear for the place. GO TIGER JACK contested the pace between rivals then on the inside, dropped back near the seven-sixteenths pole, chased on the far turn and weakened while able to get the show. MCKENNA'S JUSTICE showed early speed then was well placed just off the pace, chased two then three wide on the far turn and lacked the needed response. BARRIER REEF settled off the pace, bided his time on the far turn, was asked at the top of the stretch and failed to respond. SHAOLIN was taken in hand nearing the first turn then reserved off the pace, raced three to four wide on the far turn and came up empty. GRETSKY was taken in hand when in tight early, lagged at the rear of the field and was no factor. (Rail at 0 Feet)
