SOFIE'S PEARL chased the pace, raced off the rail on the turn, rallied along the rail into the final furlong, took the lead near the sixteenth-pole and prevailed under strong urging. HIGHER CASE showed good speed, set the pace, controlled the tempo through the turn, was asked for her best in upper stretch, led into the final sixteenth but was denied. SENSATIONAL APPEAL chased the pace, raced four then three wide on the turn and lacked the needed kick while able to get the show. MISS LADY ELLEN chased the pace between rivals, went three then two wide on the turn and tired. LIL' MARY JANE brushed with a rival at the start, was ridden along at the back, shifted out leaving the backstretch, went three wide on the turn, came four wide into the stretch and improved position. CONTUCKY DIRT was ridden along on the outside, went three then two wide on the turn and failed to rally. WIMBLETON STAR was ridden along towards the back, went two then three wide on the turn, came four wide into the stretch and also failed to rally. DARQUE SPLENDOR was rated behind the leader on the inside, dropped back a bit while in tight against the rail on the turn and gave way. DAY OF LITANY chased the pace, raced five then four wide on the turn and had nothing left. SHYLOCK'S DAUGHTER chased the pace on the far outside, went six then five wide on the turn and came up empty. (Rail at 20 Feet)
