Footnotes

CIGAR MAN was well rated while setting the pace, responded well when asked at the quarter-pole and drew clear under strong urging. CABE went three then two wide on the first turn, stalked the pace on the outside, raced three wide on the far turn, was asked near the quarter-pole, chased the winner under a drive in the stretch and was second best. UNDER OATH went four then three wide on the first turn, settled off the pace, moved in near the seven-sixteenths pole, raced inside early on the far turn then shifted three wide and narrowly earned the show. DUZY JASKO went four then three wide on the first turn, was rated just off the pace on the outside, chased four wide on the far turn and tired. COUGAR'S ARROW was taken back early then reserved while off the inside, moved closer on the far turn, was roused near the quarter-pole and came up empty. DUAL FORECAST lingered well back in the field, went two then three wide on the far turn and failed to threaten. TWO TURNS lagged towards the back, saved ground on the turns and was no factor. T. C. CHAMP was rated just off the pace, raced between rivals on the backstretch, continued between horses on the far turn, was asked at the quarter-pole and

capitulated. BADGER BO was well placed on the inside, came under urging near the five-sixteenths pole, chased into the stretch, had the rider lose his whip and weakened. SEE THE STREAK was restless in the gate, went four then three wide on the first turn, lagged near the back and showed little. DA BOYSRBACKINTOWN went three to four wide on both turns and was outrun.
