

**LONE STAR PARK - May 28, 2007 - Race 7**

STAKES Dallas Turf Cup H. Grade 3 - Thoroughbred

(PLUS UP TO \$12,000 Open ATB) FOR THREE YEAR OLDS AND UPWARD. No nomination fee. \$1,500 to pass the entry box and an additional \$1,500 to start with \$200,000 guaranteed of which \$120,000 to the owner of the winner, \$40,000 to second, \$22,000 to third, \$12,000 to fourth and \$6,000 to fifth. Weights: Sunday, May 20, 2007. Starters to be named through the entry box by the usual time of closing. High weights preferred. The field will be limited to twelve starters. Horses not drawing a starting position in the gate will receive a refund of the entry fee. A suitable award will be presented to the winning owner. Nominations closed Thursday, May 17, 2007 with 37 nominations. (If Deemed inadvisable by management to run this race over the Turf course, it will be run on the main track at One Mile and One Eighth.).

EMBOSSSED (IRE) settled off the pace, swung four wide leaving the far turn, rallied in upper stretch and closed strongly to get up late. CRESTED (GB) bobbed slightly at the start, raced three wide on the first turn, was rated on the outside, ranged up while three wide on the far turn, made a bid near the three-sixteenths pole, battled gamely in the stretch but was outfinished late. WAUPACA was well rated while setting the pace, responded well when set down leaving the far turn, battled determinedly in the stretch but was also outfinished late. MORE THAN REGAL broke a bit slow, was reserved at the back of the field while saving ground, swung out at the top of the stretch and finished well but was too late. MAJOR RHYTHM was taken back passing the wire the first time, tracked the pace on the outside, came under a ride midway down the backstretch, chased while off the rail on the far turn and weakened. BREGO was rated on the outside, came under a ride on the far turn, was in tight entering the stretch and gave way. TRIAL BY JURY raced three wide on the first turn, settled on the outside, was roused on the far turn, came three wide into the stretch, drifted out outside the sixteenth-pole and failed to rally.
