ZIGNOR dueled on the inside of two rivals, exchanged bumps with MELISSA'S MOMENT late on the backstretch, shook off rivals midway through the turn, kicked clear entering the stretch, and held under left hand urging. ENLIGHTING raced towards the front of the field, eased four wide leaving the turn, and closed strongly but was too late. MY QUEENIE was forwardly placed from the start, raced four wide on the turn, and tired in the final furlong while able to hold the show. JOANIE'S PRISSY raced well back in the field, saved ground on the turn, and finished willingly. MELISSA'S MOMENT dueled between rivals, exchanged bumps with ZIGNOR late on the backstretch, vied into the stretch, and weakened. CHURCH SECRETARY was off a step slow, raced four

wide on the turn, and improved position. ABBABOO was bumped at the start, raced near the middle of the field, and failed to rally. PLACABLE dueled on the outside, vied into the stretch, and faded. WILD SUZA raced towards the rear of the field, and failed to menace. SAVANAH GO broke outward at the start, raced four wide on the turn, and faded. MARY CHARGED IT was bumped at the start, raced near the back of the field, and showed little. RUNS NAKED raced well back in the field, and saved ground to no avail. COME FOR THE GOLD raced in the middle of the pack, went four wide on the turn, and stopped.
