RUNAWAY CHOICE tracked the pace while three wide, made a bid near the seven-sixteenths marker, vied outside of APRIL'S LUCKY BOY on the far turn, edged clear in upper stretch and held gamely under right hand urging. GOOSEY MOOSE was reserved off the pace, rallied three wide into the stretch and closed gradually. SEA DUB was well placed on the inside, shifted out in upper stretch, loomed a threat into the final sixteenth but lacked the needed kick and settled for the show. A R CRACKERS was rated off the pace, saved ground on the far turn and lacked the needed rally. TRIAL BY JURY settled towards the rear of the field, raced three wide on the far turn, came four wide into the stretch and failed to rally. ALPHA CAPO was unhurried near the back of the field, raced three wide on the far turn, came four wide into the stretch and failed to threaten. ARCHITECTURE lagged well behind the field while saving ground and never reached contention. OKIE STYLE was hard held while contesting the pace on the outside, dropped back near the seven-sixteenths marker and faded. APRIL'S LUCKY BOY contested the pace on the inside, vied into the stretch and faded.(Rail at 20 Feet)
