**Footnotes**

CAT RULER chased the pace on the outside then three wide on the turn, made a bid passing the quarter-pole, dueled gamely with MONEY SEEKER in the stretch and narrowly prevailed under strong urging. MONEY SEEKER set the pace, raced off the rail on the turn, was challenged near the quarter-pole, dueled gamely with CAT RULER in the stretch and was denied. SEMICONDUCTOR was urged along on the outside, raced four then three wide on the turn, bumped with GEORGE. A nearing the quarter-pole and finished willingly for the show. GRAND CASA showed good speed then chased the pace, dropped to the inside on the turn, swung out at the top of the stretch, moved further out outside the furlong marker and finished willingly but missed the show. BRAXTON COUNTY was urged along while off the pace, steadied near the five-sixteenths pole, raced three wide on the turn and also finished willingly. ROCK SOLID ALIBI broke a bit slow, was ridden along towards the rear, raced three then four wide on the turn, brushed with CRUSADER'S CHOICE

outside the quarter-pole and lacked the needed response. GO MITCH GO was ridden along towards the inside, steadied slightly near the five-sixteenths pole, came out leaving the turn and failed to rally. PHILLED UP was off a couple of lengths slow, raced well back in the field, moved out on the turn, came four wide into the stretch and reached his best stride too late. VALIDO chased the pace on the inside, saved ground on the turn and tired. GEORGE A. chased the pace, bumped with SEMICONDUCTOR nearing the quarter-pole and came up empty. CRUSADER'S CHOICE was ridden along while off the pace, raced four then five wide on the turn, brushed with ROCK SOLID ALIBI outside the quarter-pole and failed to respond. H. C. MYSTERY was ridden along near the back, raced four wide on the turn and was no factor. (Rail at 10 Feet)
