DOC'S DELIGHT raced four then three wide on the first turn, tracked the pace on the outside, ranged up on the far turn, made a three wide bid passing the quarter-pole, kicked clear in upper stretch and held well under strong urging. HAWAIIAN SKY raced between rivals on the first turn, was rated off the pace, chased three to four wide on the far turn and lacked the needed kick while able to get the place. WEEKEND CONNECTION was reserved towards the back of the field, shifted four wide near the quarter-pole and finished willingly for the show. GINNY'S PIG contested the pace on the outside, vied into the stretch and weakened. MACHO MON contested the pace on the inside, vied into the stretch and gave way. SPRING OF LIFE settled on the inside, saved ground into the stretch and dropped out. POINT CHANEL lagged at the rear of the field, saved ground on the far turn and failed to threaten. CRYPTO SUNSET was in tight entering the first turn, raced three wide on that turn, settled on the outside, was urged along while three wide on the far turn and failed to respond. (Rail at 20 Feet)
