MCKENNA raced up close while between rivals, came four wide into the stretch, and earned the place. DAISYE DUXSTER was forwardly placed on the inside, saved ground into the stretch, and was along for the show. CHURCH SECRETARY raced well back into the stretch, and improved position. WAITONME was allowed to settle into stride, raced four wide on the turn, and faded. JOANIE'S PRISSY raced well back in the field, and saved ground to no avail. COME FOR THE GOLD raced towards the back of the field, and failed to threaten. SUNRISE MISS raced five wide leaving the turn, and was always outrun. PLACABLE raced up close while on the outside, vied past the quarter pole, and faltered. EBONY POST was hustled from the start, contested the pace on the inside, and stopped.
