BOBBIE DAN bumped with a rival at the start, chased the pace, made a rail bid passing the seven-sixteenths pole, shook clear leaving the turn and drew off under strong urging. MACHO SISTA was ridden along on the far outside, went five wide on the turn, gained some while six wide into the stretch and narrowly earned the place while no match for the winner. UNMERITED FAVOR bumped with a rival at the start, was urged along on the outside, came in near the seven-sixteenths pole and shut-off SWEET SUGARPLUM, went three to four wide on the turn and narrowly missed the place. CEE CEE GRAND broke out and bumped with a rival, chased the pace on the outside then five wide on the turn and tired then missed the trifecta. LEGAL CHOICE showed speed then chased the pace, made a bid near the seven-sixteenths pole, vied four wide on the turn and weakened. ARTIC IGLOO was ridden along while off the pace, saved ground on the turn and failed to threaten. SOONER RUN was urged along towards the rear, raced off the rail on the turn and failed to respond. SWEET SUGARPLUM broke a bit slow then was shut-off and taken up, raced at the back while ridden along, moved up some near the half-mile pole, checked sharply when UNMERITED FAVOR came in at the seven-sixteenths pole, went three wide on the turn and was no factor in a tough trip. MO MOVE contested the pace, vied three then two wide on the turn, dropped back near the five-sixteenths pole and faded. ANA'S DANDY bumped with a rival at the start, disputed the pace, vied between rivals early on the turn and stopped.
