### Footnotes

G G'S GIRL contested the pace on the inside, inched clear leaving the backstretch, drew off in upper stretch and proved much the best under steady urging. WATERTOWN ROAD lagged at the rear of the field, was ridden along on the far turn, shifted three wide near the quarter-pole, moved out once straightened for the drive and got up for the place. DAKOTA ADIEU went four to five wide on the first turn, settled on the outside, chased three wide on the far turn and weakened while able to get the show. MAYMEISTER was rank early, went three to four wide on the first turn, settled on the backstretch, was urged along while off the rail early on the far turn, shifted four wide nearing the quarter-pole and failed to rally. PERFECTLY WICKED settled towards the rear, came three wide into the stretch and failed to threaten. BROADWAY ALI went two to three wide on the first turn, contested the pace, chased on the far turn and tired. MOLLY MAGNOLIA was well placed just off the pace, raced inside on the turns and came up empty.
