### Footnotes

UNBRIDLED'S HEART was well rated while setting the pace off the rail, came under some urging on the far turn, drifted out under a left-handed whip at the top of the stretch, responded well thereafter and held under strong urging. ROYAL AGO raced inside on the first turn, settled off the pace, was urged along while off the rail on the far turn and lacked the needed kick while able to get the place. QUE DESEO was rated on the inside, chased on the far turn, came a bit off the rail at the top of the stretch, held a good striking position into the final furlong but also lacked the needed kick and missed the show. MCKENNA'S JUSTICE brushed with rivals in the early going, settled on the outside, was roused while three wide on the far turn and lacked the needed response. TWILIGHT BAY brushed with a rival in the early going, raced three wide on the first turn, was unhurried near the back, came under some urging while off the rail on the far turn, lacked room passing the quarter-pole, moved in at the top of the stretch, shifted out near the sixteenth-pole and also lacked the needed response. STAND was asked from the start, brushed with a rival early and was in tight briefly, settled on the inside, saved ground through the far turn, checked when TWILIGHT BAY came in at the top of the stretch, moved out outside the furlong marker and failed to rally. BACKSTABBER raced three wide on the first turn, was rated just behind the leader, chased three wide on the far turn and tired. (Rail at 10 Feet)
