CAT VANBLU contested the pace on the inside, shook clear in upper stretch and held under strong urging. PHARME'S PHIRE settled on the inside, saved ground through the far turn, rallied in the final furlong, moved out near the sixteenth-pole and closed well but missed. DEMURE HALO was well placed on the inside, shifted three wide near the quarter-pole, chased the winner into the final furlong and finished willingly for the show. MISS HOCKADAY broke out at the start, lagged at the rear of the field, moved out on the far turn, shifted five wide near the quarter-pole and also finished willingly. OKIE BLONDE settled towards the rear while off the rail, was roused at the top of the stretch, moved out near the furlong marker and finished with late energy. FLOATNPASTYA disputed the pace on the outside, vied into the stretch and gave way. OCEAN AHUMIN went three wide on the first turn, settled on the outside, was urged along while two to three wide on the far turn, moved to four wide near the quarter-pole and lacked the needed response. (Rail at 20 Feet)
