**Footnotes**

B G GOLDEN TIME was hustled from the start, dueled on the inside, came off the rail near the quarter-pole, kicked clear at the top of the stretch and held well under right hand urging. HUNG UP was off slow then forced out, raced on the outside while ridden along, went four to five wide on the turn and finished willingly for the place. NOON DELIGHT chased the early pace then dropped back, raced off the rail on the turn and finished willingly for the show. I KNOW JOE dueled between rivals, was pinched back entering the turn, raced three then two wide on the turn and failed to rally. DEBBIE WAS MINE was returned to the paddock for a new rider, broke outward at the start, showed no speed, saved ground on the turn and improved position. MASTERS CROWNJEWEL dueled on the outside, vied two to three wide on the turn and tired. TIGER'S SPLENDOR threw his head late on the backstretch, lugged out a bit while four wide on the turn and was not urged in the stretch then pulled up in distress after the finish and was vanned off. UP FOR THE FIGHT chased the pace, raced three to four wide on the turn and came up empty. MISTY VISIONS dueled between rivals, dropped back near the five-sixteenths pole then moved to the rail and capitulated. B G MISS MEIMY chased the pace, dropped back under a hold nearing the turn, saved ground into the stretch and failed to respond. (Rail at 0 Feet)
