No nomination fee. \$2,500 to enter and an additional \$2,500 to start with \$100,000 guaranteed of which \$55,000 to the owner of the winner, \$17,000 to second, \$10,000 to third, \$5,000 to fourth, \$3,000 to fifth, and \$2,000 to sixth through tenth. If less than ten horses start, the purse money not distributed will revert to the winning owner. High weights preferred. Total earnings in 2011 will be used in determining preference of horses assigned equal weights. Startersto be named through the entry box by the usual time of closing. The field will be limited to ten starters. Horses not receiving a starting position in the gate will receive a refund of the entry fee. A suitable award will be presented to the winning owwner. Nominations closed Thursday, September 22, 2011 with 25 nominations.
