MRS. GUILTY rated back, strong middle move, collared foe turn, drew off. PREMIER AMOUR off slowly, varied little backside, rallied last turn, 2nd best. LEEWARD BREEZE made early lead, set pace, overpowered turn, weakened. DEVIL'S MUSIC dropped back, altered course, passed tiring rivals. DESERT WELLS well placed, tracked to 1/2, faded off, evenly lane. SAONE RIVER caught wide early, rushed move second turn, wore down late. PAINT THE WIND sent inside, chased to 1/2, wilted turn, gave way. RUTHLESS MCGREGOR away alertly, pursued backside, flattened out. THAT'S A COVE saved ground, done early. WHISPER AND RUN step slow, gave way, eased to wire.
