Footnotes

LADY BRADFORD crowded start, evenly to lane, forced inside, surged up gamely. SNOGUN rushed to front, pressed pace, shook clear lane, out gamed late. RIZZI GIRL slow early, fired leaving turn, blocked, found room wide, rallied. WHISPERED ILLUSION went evenly, saved ground, mild rally lane, leveled off inside. SWEET RUBY bore out at start, hustled along, wore down in drive, faded. ELAINA squeezed at start, well back early, no factor. CLASSIC IMAGE jammed at start, hustled wide, wore out. FLYING WITH ANGELS away alertly, dueled inside to 1/4 pole, wilted drifted out lane. SKY JIVING off slowly, always outrun. WEEZY in tight start, no factor. Objections were lodged by RIZZI GIRL against LADY BRADFORD for interference at the top of the stretch and CLASSIC IMAGE against SWEET RUBY for interference as horses left the starting gate. Both objections were disallowed by the stewards.
