LEXI'S ARGUMENT moved on pace shaking off DYNABOX to clear into the far turn, dug in from the two path holding firm the final eighth. ABELIA unhurried early advanced to threaten on the far turn, extending outside of LEXI'S ARGUMENT down the stretch made no headway while securing place. SAINT CINDY rated back early was roused to contention on the far turn, extending in the two and three path down the stretch would hang. DANCINGTHENITEAWAY tracked the pace through the backside giving chase on the far turn, saved ground to upper stretch angling out during the drive weakening late. SOUTHCOTE ROAD breaking slowly was never involved. DYNABOX set the pace on soft splits through the backside, weakened on the far turn giving way into upper stretch. MISS QUICK PUNCH stalked the pace through the backside then folded up on the far turn.
